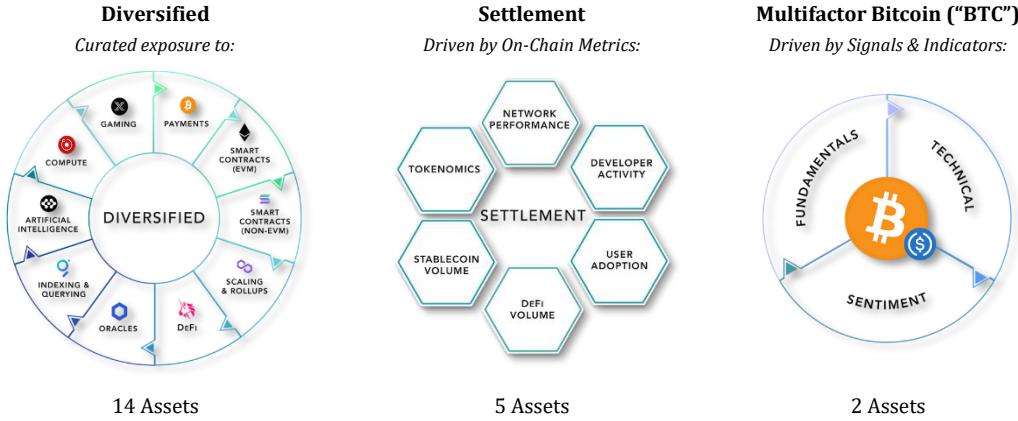


Digital Asset Model Portfolios

Overview



Diversified

Multi-vertical exposure to a hand-selected portfolio of coins and tokens spanning Smart Contracts, Payments, DeFi, Infrastructure, and Culture. Suitable for investors seeking to expand their digital asset investment exposure across an array of blockchains and project-specific protocols.

Settlement

Targeted exposure to a specific group of industry leading L1/L2 blockchain networks, driven by Khelp's fundamental framework. Suitable for crypto investors who are looking to add selective, yet multi-asset crypto exposure to diversify their broader investment portfolio.

Multifactor Bitcoin

Momentum-driven model that uses a range of indicators and signals to identify trading opportunities by timing market entries and exits; aims to improve on a long-term buy-and-hold BTC approach.

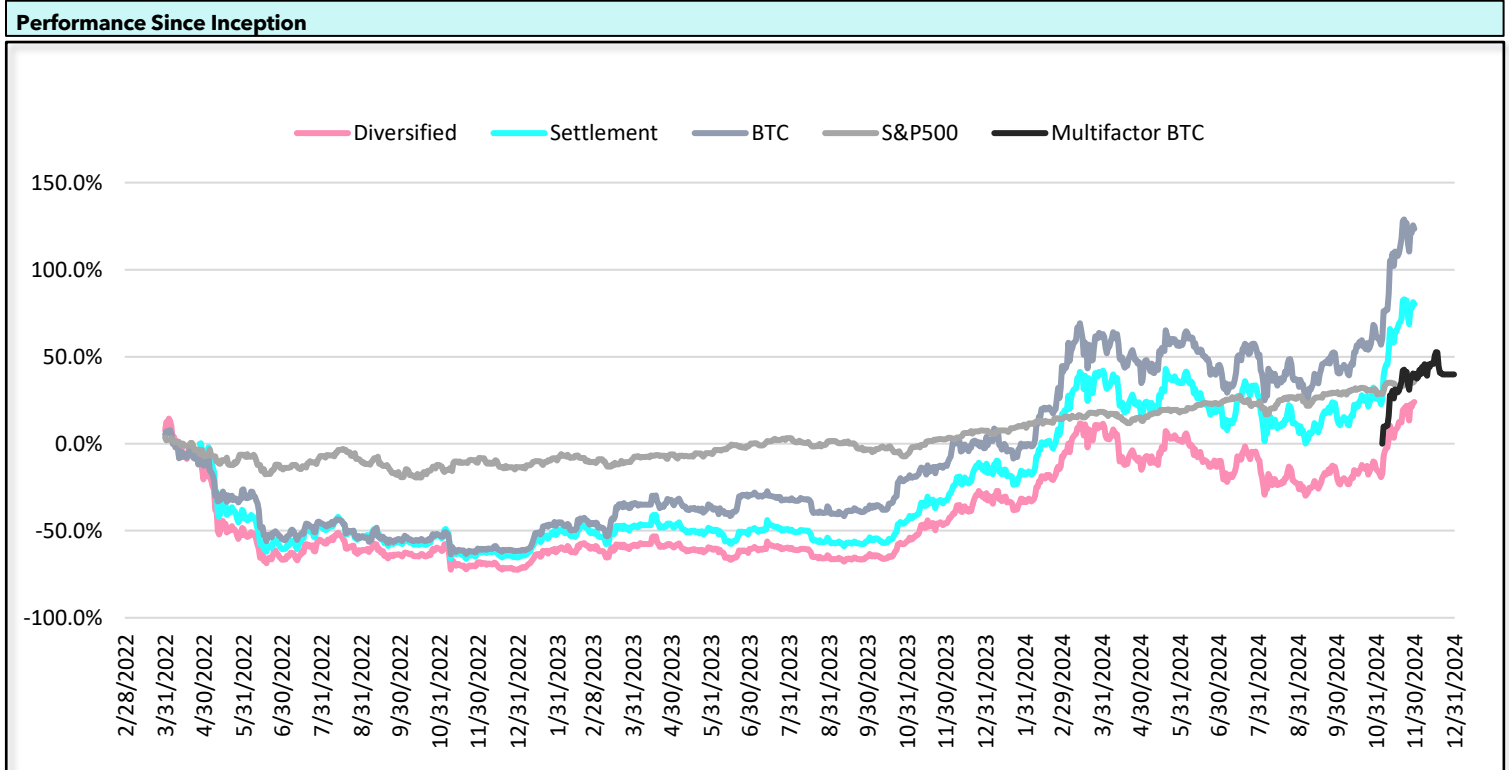
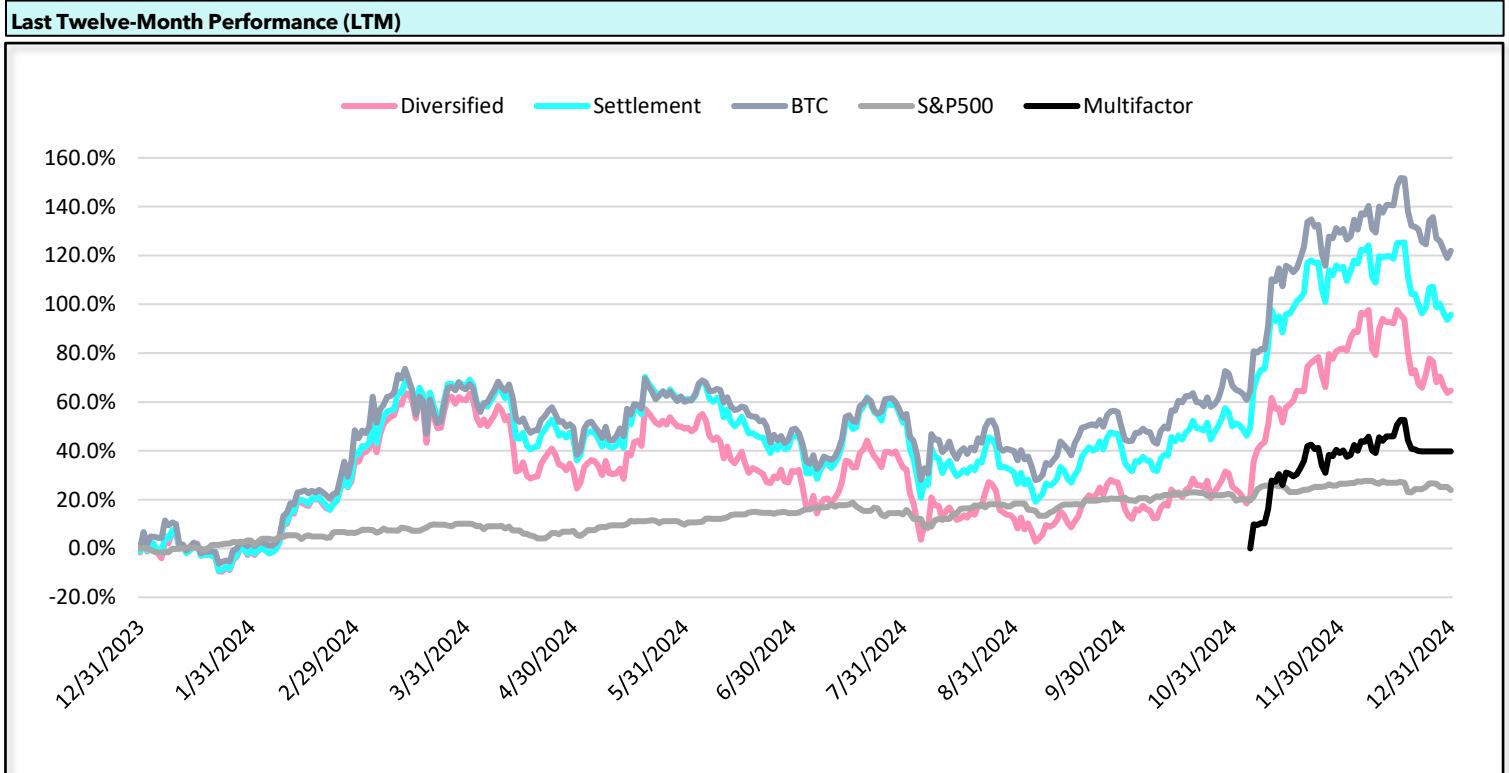
